In the event there are insufficient nominees or no nominees for an office or offices and a timely petition is not filed pursuant to section 5326 of the Education Code, an appointment will be made.

In the event that there are no nominees to an office or offices, the governing board of the district shall, prior to making any appointment and in accordance with section 5328.5 of the Education Code, notify its residents that it intends to make an appointment or appointments. This notice shall further inform such residents of the procedure available for applying for said office or offices.
